GUIDELINES FOR SCHOLARSHIP APPLICANTS - 2010

- (1) **Scholarships are available to active members in good standing of the Legacy Savings and Credit Union for a period of one (1) year prior to application for a scholarship.**
- (2) Scholarships are available to members who have completed their Grade 12 within the 2 years preceding this application, and are entering a post secondary institution for the first time.
- (3) Successful recipients of a Scholarship will be allowed a free choice in the selection of an accredited school of learning.
- (4) Academic merit will be the first consideration in awarding scholarships.
- (5) Documentary evidence of marks is to be provided by the applicants for Scholarships and must accompany applications for Scholarship.
- (6) All applicants for Scholarships are to be in the hands of the Legacy Savings & Credit Union not later than August 20, 2010 without exception.
- (7) Awards will be distributed by the Board of Trustees only after the successful recipient has been accepted at the Institution of his choice.
- (8) Awards will apply to the term immediately following the award.
- (9) Successful recipients of awards are not allowed to apply again.
- (10) Applicants are required to submit a copy of an **OFFICIAL HIGH SCHOOL TRANSCRIPT OF ACHIEVEMENT from ALBERTA EDUCATION.**
- (11) Scholarship applicants will have their names and photographs published in the "Legacy Savings & Credit Union" newsletter and on the "Legacy Savings & Credit Union" website.
